**MH-001-2013 Compliance Filings
Guidance on Filing a Letter of Credit or a Surety Bond**

As part of the MH-001-2013 Reasons for Decision (Decision) ([Filing A60675](#)), the National Energy Board (Board) required all companies, with the exception of those setting-aside funds in a trust or otherwise exempted, to file for approval a letter of credit or a surety bond by 31 December 2014. The Board provided a model letter of credit and a model surety bond in Appendix XI and Appendix XII of the Decision.

Please see the following guidance for submitting of a letter of credit or surety bond to the Board:

- Submit the original letter of credit or surety bond to:

- Include a cover letter referencing File No. OF-AF-SAC 04.
- Submit the cover letter electronically on the [Electronic Document Submission](#) (System). Do not file a copy of the letter of credit or surety bond on the System.

A complete list of companies required to file a letter of credit or surety bond is attached as Appendix 1. The Board reminds pipeline companies that compliance with Board orders is not optional. The Board has the ability to compel compliance through its enforcement process.
